### Jurisprudence Examination Implementation:

CDPEI has developed a jurisprudence examination to support its mandate of protecting the public by ensuring registrants understand the legislation, standards, and professional expectations governing dietetic practice in Prince Edward Island.

While it is an examination, its primary purpose is to serve as an educational refresher on the regulatory framework that supports safe, ethical, and competent practice.

The jurisprudence examination will become part of Continuing Education requirements and must be completed once every three years, following the current CE audit process.

The requirement will take effect April 1, 2026, and CE audits beginning with the 2027 renewal will confirm completion of the exam for the 2026–2027 CE cycle.

CDPEI Council has approved a [Reinstatement After 3 Years Policy](#). This policy sets out the assessment criteria used by the College to determine when an applicant has sufficiently demonstrated the currency of their knowledge, skills, and competence after resigning their license to practice in a Canadian jurisdiction greater than 3 years ago.
